

## 420 House Concert Official Rules

**1. This Contest** is open only to those who sign up at the <http://cannabisnowmagazine.com/giveaways/win-free-420-house-concert> and who are 18 years old as of the date of entry. The Contest is only open to legal residents of The United States, and is void where prohibited by law. Employees of The Family Management, Inc. (“Company”), O2 Records, Inc., 420 House Concerts & Cannabis Now, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

Winner must be able to provide adequate location and security for Artists vehicle and equipment. The specifics of the prize shall be solely determined by Company.
